American Coptic Union Submits Complain Against Mubarak Regime

On August 17, 2010, the ACU issued a complaint on behalf of the oppressed Coptic Christians of Egypt to the OHCHR. This complaint was filed against President Hosni Mubarak of Egypt; Interior Minister Muhammed Habib AlAdley; Chairman of Committee of Policies of the NDP (ruling party) Gamal Mubarak; Speaker of Parliament Fat'hey Suror; and Speaker of Shura Council Safwat ElSherif. They are accused for their criminal policies and practice of crimes against humanity and genocide against Coptic Christians in Egypt. The crimes include:

- Ethnic cleansing against hundreds of thousands, displacing and forcing families to leave their homes, and lands. And Confiscations of private properties.
- Massacring of Egyptian Copts, terror attacks, and raids on Coptic Christian villages.
- Thousands killed in orchestrated attacks all over Egypt.
- Kidnapping, raping, more than 500,000 women, and underage girls, forcing them to convert, and marry of those who commit the crime against them- continue P 2

According to sources in AlMinia Province and conversations with Anba Agapios, bishop of the dioceses of Delga and Deir Mawas, Kamila was never physically seen by anyone including her husband and father. Disappearance is distortion and propaganda against the church by Governor Ahmed Diaa Aldin of AlMinia to tear down Der Mowas Church.

Newspaper Al Massry Alyoum reported that Kamila was found and returned home. According to the ACU's investigation, this information is not accurate. Not a single picture or interview by the press were released to prove that she is free. The ACU is concerned for the well being of Kamila because this is not an unprecedented case. In 2004, Wafaa Kostantine, also the wife of a priest, was kidnapped and forced to convert to Islam by Muslim extremists. Wafaa was "found and given" to the church. She was never seen again. A fanatic sheikh claimed she was killed while imprisoned in the Anba Bishoy Monastery.

On Monday, July 19, 2010, Kamila disappeared. Father Tedaos, her husband, said he was at his parents' with his young son while his wife was at another school for her job. He returned home to find his wife missing from the previous night.

The second issue regards terror tactics employed against the Copts by the AlMinia governor and the Mubarak regime in the province. Recently, Governor Aldin ordered the destruction of the oldest churches in the Maghagha area. The disappearance of the two children, Martha and Mariam, on June 21, 2010 in Badraman, AlMinia is part of Mubarak's campaign against Christians.

The third issue focuses on the same terror policy imposed in Suhaj, Egypt. Recently, more than 10,000 Copts protested the police attack on one of the oldest graveyards in Akhmim, Egypt. The graveyard goes back thousands of years. Although the graveyard is the private property of the families in the area, General Mohsen Al-Nomany, the governor of Suhaj, thinks otherwise; he denies the Coptic ownership of the graveyard. According to various media reports, the police seized and scavenged the graveyard for antiquities and ancient artifacts. The police arrested more than 250 Copts at the protest. They dispersed the protesters with tear gas and batons. A curfew was imposed on the entire city.

Open Letter to all Coptic Christians from P. 2

to God for help, they must learn to help themselves. Let me briefly remind the Copts of the history they seemed to forget.

Ancient Egypt is the oldest civilization on earth. For about 2300 years, the Egyptians were split into various tribes, each with their own set of laws and religion. Around 3200 BC, King Menes united Upper and Lower Egypt. From that moment on, Egypt was a united nation. The Egyptians built hundreds of monuments that continue to perplex scientists and archaeologists. For instance, the pyramid Khufu (the largest of the pyramids) points directly at the North Star. NASA and other agencies still cannot explain how the Egyptians pulled off the astronomical feat. Ancient Egypt was also the place of origin for early Christian doctrine, as proven by the Book of the Dead and King Akhenaton, father of King Tut. The Book of the Dead was an Egyptian mortuary text containing “spells” that ensures the afterlife of the Pharaohs. It contained a set of laws that became the basis for Christianity: the Ten Commandments. “I have not killed” became “Thou shall not kill;” “I have not been unchaste” became “Thou shall not commit adultery.” Akhenaton furthered the origin of Christianity when he embraced monotheism. Many historians today believe Akhenaton was the first human being to believe in one God. According to Akhenaton, there was only one God: the Sun God, Ra.

These are just drops in an ocean of the glorious history of the Copts. However, this is not meant to say the Egyptians are superior to any other race; no, this is only to remind the Copts of their contributions to humanity and why they must fight for their human rights.

As the centuries went by, Egypt’s neighbors grew stronger through trade with Egypt. The Egyptians, confronted with disunity, were conquered by the Hyksos, and later, the Libyans, Nubians, and Assyrians. However, when the Egyptians acknowledged their common enemies and finally united, they drove off the invaders and reclaimed their land. However, this was not the end of foreign rule. The Persians, followed by the Greeks, Romans, Byzantines, Arabs, Turks, and English would rule Egypt. The Egyptians would never reclaim their lands again.

Today, the Copts face oppression in their own land. Over 500,000 Coptic girls were kidnapped since President Hosni

Mubarak took office. The girls were forced to convert to Islam, raped, or killed. There is a constant fear to let Coptic children leave the house in Egypt. No human being should be forced to live in fear in their land. Coptic villages are raided and pillaged on a daily basis. Churches are burned and massacres continually go unnoticed by the government. There are a myriad of problems confronting the Copts yet they continue to let the government make it out to be a religious problem rather than crimes against humanity.

The only way for the Copts to gain their civil rights is for them to gain their human rights first. The Copts faced oppression, genocide, ethnic cleansing, and crimes against humanity. They have a legitimate case for the United Nations Human Rights Council. The only thing holding the Copts back is the Copts themselves. immediately to build Cordoba mosque in Ground Zero location, while they suspiciously showed procrastination to permit re-building the Greek Orthodox Church that destroyed in 9/11 attacks and was already stand at that location, also they did not seriously investigate a fire in a Catholic church in the Bronx which served the people of this Community.?

However, that Mosque was not built for the sole purpose of worship. No, it was built by Islamists to pursue an anti-Christian agenda in the United States. Some numbers are helpful in answering this important question. The number of Mosques and Islamic centers in 2001 were about 1500. Now, there are more than 6000. While Catholic churches, schools, and hospitals are going bankrupt and closing down, Islamic places of worship increased tremendously in the last decade.

There are reasons why Islamists want to build the Cordoba Mosque in New

York City. First, Islamists already acquitted before American's public opinion from the 9/11 attacks. Second, since New York City is home to quite a number of Jews, the Cordoba Mosque is a gesture of peace from the Islamists. This is a reminder to them of their past cooperation in Andalucía during the Arab occupation of Spain.

We have no intention of hurting the feelings of Muslims. Our main concern is politicizing Islam in a way that divides American society by creating religious alliances. Christian communities in countries such as Egypt, Lebanon, Iraq, and the former Yugoslavia face their worst period in history because of political Islamization and anti-Christian agendas. There is an anti-Christian crusade on Christians and Western culture.

The anti-Christian movement is gaining more influence every day, helping Islamists at the expense of Christianity. In Europe, numerous incidents show Muslims being "persecuted" by depriving them from building

Minarets in Switzerland and wearing the Burqa (veil) in France. At the same time, Mosques are being built and Islamic centers are expanding services to convert Christians. Legislation and court orders are issues to limit Christian culture and practices in Christian countries in order to avoid hurting the feelings of Islamists.

In England, for instance, the Bishop of Canterbury, the origin of British and American Christianity, supports Sharia law for Muslims instead of British common law. Despite hundreds of Mosques across England, the Bishop allows Muslims to use churches for prayer. In Italy, the crucifix is now banned in Italian schools to destroy Catholic Christianity.

In America, anti-Christian sentiment is booming. The Catholic Church is facing an existential threat. The Coptic Orthodox church is under severe pressure from the Mubarak regime's intelligence agency, a main partner in the anti-Christian alliance. Other Christian denominations are infiltrated by anti-Christians

as well.

Even some churches are helping the anti-Christian movement by generating sympathy for Islamists. They depict Muslims as being deprived from freedom of religion and persecuted. This is designed to fool the American people into sympathizing with Islamists. For instance, a church in

Gainesville, Florida decided to burn the Quran, the book of Islam. This is not Christian practice

to burn any book. Churches during the pagan and heretic periods of history did not even do

this. The Gainesville church also gave the al-Azhar institute a chance to condemn Christians and show that Muslims are persecuted. The church in Gainesville must cancel its plan immediately.

Anti-Christian policy is evident even in domestic issues such as immigration. The anti-Christian movement in America is targeting Catholic immigrants from Central and South America trying to escape the capitalist-imposed poverty in their respective countries. According to the 2004 Kennedy-McCain Immigration Bill, approximately 700,000 illegal immigrants enter the United States annually. On the other hand, thousands of international flights land every day with people from the Middle East and Asia staying illegally in the US after their Visas expire.

Anti-Christians have had tremendous success in helping Islamization destroy Christianity in the United States, Europe, and the Middle East. Although it is widely known and documented that Saudi Arabia and Egypt perpetrated the 9/11 attacks, US foreign policy considers these countries to be “strong allies” and “close friends.” They allowed expanding

Islam to hurt Christianity under the banner of “peace in the Middle East.” No one seems to hold 9/11 against these countries. Instead, they are rewarded without impunity. September 11 conspiracy is not over yet.

Mubarak's Regime Continues to Raid and Loot the Tombs of the ancient Egyptians, the ancestors of the Copts

The recent events directed at the Coptic Christians of Egypt are not only despicable, but contribute to the cultural genocide of Egypt and its sons. The Copts face genocide, ethnic cleansing, rape, and kidnapping on a daily basis. Hundreds of Coptic businesses and churches are also destroyed every year, further condemning the Copts to dictatorship and leaving them defenseless against oppression. Since the Copts cannot defend their rights, the government under President Hosni Mubarak continues to raid and loot the tombs of the ancient Egyptians, the ancestors of the Copts.

Recent months featured the unearthing of dozens of tombs of ancient Egyptian pharaohs, including 57 burial places discovered in Al-Fayoum. But what is to say that these archaeologists are not hired by the Mubarak regime rather than an independent organization? Reports from the *New York Sun* and *Huffington Post* indicate that several ancient Egyptian artifacts and art were stolen from tombs. The Mubarak regime continues to excavate in upper Egypt and refuses to explain the sudden disappearance of these ancient artifacts. Yet, the international community continues to ignore these cultural crimes because they have regional and political interests with Egypt.

The Mubarak regime also employs the policy of eminent domain, or the taking of private property, for its own use. The government seizes Coptic graveyards in one of the oldest cemeteries in **Akhmim, and Luxor in Upper Egypt**, They remove tombs and caskets without regard for the Copts' rights to property. The graveyards are then sold to foreign investors and corporations.

The American Coptic Union (ACU) asks UNESCO to do the following:

1. Condemn the actions of the Mubarak regime regarding ancient artifacts and property owned by the Copts.
2. Demand the return of the stolen artifacts and property back to the Coptic people.

Implement policies and regulations designed to prevent further looting and corruption by the government in the ancient tombs

Anti-Christian sentiment, not Islamophobia

The City Council and Mayor Bloomberg of New York City have committed a strategic mistake

Over the last few days, Muslims and anti-Christian groups stood on the Ground Zero site carrying signs that defend freedom of religion for Islamists. Although there were a small number of people at the site, the media was heavily covering their gathering. Some signs rightfully denounced Pastor Terry Jones's call to burn the Quran on 9/11.

The issue of freedom of religion in Islam is not profoundly discussed among American people. Islam does not allow freedom of religion for a non Islamic religions in countries where Islam rules. Non Muslims can't easily worship in peace even inside their homes. They are treated as infidels and second-class citizens. Almost all of their basic rights are denied.

The United States Constitution guarantees freedom of religion for all religious groups. The question is: Should the United States allow freedom of religion for a religion that denies this basic right to other religions?

We challenge Sheikh Raof and Mayor Michael Bloomberg, who supports the Cordoba Mosque on the basis of religious freedom, to write and ask together, for similar treatment, to the Saudi King requesting a Synagogue and Church to be built in Mecca and Medina. This will be a test for the so called "freedom of religion" in Islam, or lack thereof. He must prove Islam's "religious tolerance" by allowing Jews to pray in Al-Aqsa Mosque that once stood as part of Jerusalem Temple, and Christians to worship freely and practice their religion without harassment.

The City Council and Mayor Bloomberg of New York City have committed a strategic mistake in allowing the a political fanatic Muslim faction, Muslim Brotherhood, which is not considered a main stream Muslim in the Islamic World, to build a Mosque as a base for extremism and hatred on the site of

9/11 attacks, or any other places. Sheikh Abdul Raof is an active member of the Muslim Brotherhood, in addition to being a cousin of Hasan Al Banaa,, the founder of the Muslim Brotherhood in the Muslim World in 1928.

During the last nine years of Mr. Bloomberg's mayorship, many Churches and Christian schools closed and declared bankruptcy because of pressure from anti-Christian groups in New York City under his watch. Freedom of religion should be respected. Thus we call upon the Mayor, to help rebuild, and reopen these Christian institutions for the common good of their communities.

Freedom of religion is a two way street. During the Cold War, America and the West allowed citizens of communist countries to come and live freely. Communism, however, was not allowed because it does

not acknowledge freedom. Islam does not allow freedom of religion, and other freedoms in Islamic countries too.

Seizing 9/11 Memorial Day, the anti-Christian media, and News portrayed Pastor Terry Jones as a villain while

Sheikh Raof was portrayed as the angel of compassion. The media conveniently ignored the fact that Raof is the cousin of Hassan El-Banaa, the founder of the Muslim Brotherhood in Egypt. This Mosque, if built, will be the foundation of the Muslim Brotherhood and their fanatic teachings in America. More mosques will follow as chapters for the Muslim Brotherhood. They will be acting as a bridge with the Wahabbi in Saudi Arabia. Our experiences in Egypt and the Middle East tell us that these mosques will be used as launching pads against Churches, properties, women, and children. The Muslim Brotherhood and other Islamists as well as, the Mubarak regime,

embrace a policy of genocide against the Egyptian Coptic Christians and other Christians in the Middle East, that also ignored by the US main stream Media.

Anti-Christians and Islamists in America are paving the way for future confrontations, dividing Christian denominations, and planning social unrest in the future. Their weapons will be abusing the freedoms provided in the US Constitution. As a consequence, new legislations will be passed, including amendments to the Constitution, to fit the need of this new situation. Religious riots, martial law, and dictatorship will follow with the help and support of anti-Christians.

The media was very biased with Imam Abdul Raof, who was portrayed as an angle of compassion, while crucifying Pastor Jones for honoring the victims of 9/11. Pastor Jones acted as a “snake” as Jesus told us when we face anti-Christians. Thus, he used “a ruse to trick Satan.” While he practices his freedom of expression,

as guaranteed by the First Amendment to the US Constitution, to honor 9/11 victims, Sheikh Raof insists on using his rights to dishonor the American blood of the victims and indignifying their lives. Unlike anti-Christians and Islamists, Pastor Jones did not conspire with Osama bin Laden against Americans. Although Pastor Jones’s plan to burn the Quran was not the best way in handling the situation, it opened up negotiations with anti-Christians to honor the victims of 9/11. However, we were surprised when many media analysts denied his rights as a pastor for defending the rights of 9/11 victims, while praising Sheikh Raof indignifying the victims. Secretary Gates and General Petraeus talked to Pastor Jones. They voiced their concern regarding the Quran burning, saying it would put the lives of US troops in Afghanistan and Iraq at risk. He responded



positively, as a Christian and American patriot.

The media acted like the Islamic media of the Middle East by attacking Christianity and the Pastor. And even worse than Hama’s, Al Aqsa Channel, and ,Al Manar, Hezbollah Channel. They used personal and character assassination to distort what he represents and to distract the American people from the main issue: the anti-Christian movement in the United States and the upcoming danger to Christians.

Despite cancelling the Quran burning event to open negotiations with Sheik Raof, Pastor Jones was still bombarded with vicious attacks by the media. It was a shame and a disappointment for the mainstream media depicting the Pastor as a terrorist.

Another shameful tactic by the media was broadcasting American Christian clergy of different denominations

who defend anti-Christians and Islamists. Our experiences in the Middle East show that such clergies never show love for their own people or congregations: they always took the side of the Islamists in Egypt. Christ’s teachings were abused by such priests when it was against the interests of Christians. For instance, the clergy never teaches its people to be as “wise as snakes” and not as “doves” all the time.

We would like to alert our American brothers and sisters to be cautious and weary of those who use the word of our Lord Jesus Christ to promote the word of his enemies.

Islamic history books will depict the first Muslim Brotherhood mosque as a monument to Osama bin Laden’s victory in New York invasion, as he described in one of his tapes.

Despite the dark picture drawn by the anti-Christian media, there are some good

touches. First, President Barack Obama called to cancel the Quran burning event. Second, the former Speaker of the House called took a fair position with Pastor Jones, and support him for the relocation of the

Mosque as well as, cancelling the burning. Moving the mosque does not diminish the Muslims' right to build a house of worship even though it is a Muslim Brotherhood mosque.
